D. **BOARD PROCEEDINGS:**

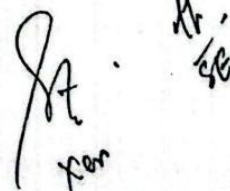
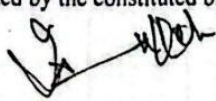
In compliance to the Secretary, Communication & Works Department Gilgit-Baltistan vide Office Notification No. Sec-SO-D-9(18)/2023-24/3280 dated 4th September, 2025, the Executive Engineer Building Division Gilgit was directed to submit the relevant record/ document to the constituted GRC vide letter No. 2(293)/Dev-I/2023-24/1430 dated 09th September, 2025. In compliance, the Executive Engineer Building Division Gilgit has submitted the available record / documents through rep. of Building Division Gilgit.

The board members assembled in the office of the Superintending Engineer Diamer-Astore Circle (camp office HQ Gilgit) on 12th September, 2025. The board members thoroughly examined and scrutinized the record i.e. the PC-1 provision, T/S Estimates, Evaluation criteria, Tender notice, evaluation sheet, broacher of the aggrieved bidder etc and briefed / summarized as under:

E. **Findings:**

After detailed deliberation and scrutiny of record, the following observed:

1. The tender notice was published by Executive Engineer Building Division Gilgit vide office letter No. AB/Notice(SSTE)/2024-25/644 dated 23rd June, 2025 to be opened on 15th July, 2025. The bid was opened on same scheduled date under Single Stage Two Envelope (SSTE) bidding procedure and 06 Nos constructors / Firms / JV applied and evaluated by the constituted bid evaluation committee as per evaluation criteria.



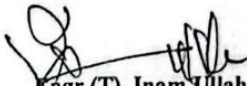

2. The bid evaluation committee notified that only 03 Nos constructor qualified while 03 Nos stood non-responsive. Among them, 01 No constructor, M/s Amir Haider & Sons declared as "Non-Responsive" due to "non-provision of renewal receipt with C&WD for the year 2025-26". The contractor approached to the Secretary, Communication & Works Department GB for constitution of Grievance Redressal Committee (copy attached as Annex-A). Accordingly, the GRC constituted by the competent authority as per GB-PPRA rules 2022 rule-51.
3. The GRC scrutinized the record and found that:
 - I) as per mandatory conditions mentioned in invitation for bid there was no condition of renewal receipt of Works Department for the year 2025-26. (Copy attached as Annex-B)
 - II) As per evaluation criteria, M/s Amir Haider & sons failed to qualify because he did not possess renewal receipt of Works Department for the year 2025-26.
 - III) The contractor M/s Amir Haider & sons has valid registration with Pakistan Engineering Council for the year 2025-26.
 - IV) There is conflict between the notice inviting tender and bidding documents regarding the renewal of PEC license. Bidding documents used also needs corrections.
 - V) The aggrieved bidder name is erroneously written as Amir Abbas & Son's in the notification issued from the office of Secretary Communication & Works Department GB which also needs correction.

F. Recommendations:

The Grievance Redressal Committee is of the view that the aggrieved bidder has renewed Pakistan Engineering Council (PEC) license as per mandatory conditions of the notice inviting tender and bidding documents. The bid evaluation committee should be directed to evaluate the technical bid of the aggrieved bidder as there is no mandatory condition of renewal with Communication & Works Department GB in the Tender Inviting Tender and bidding documents.
