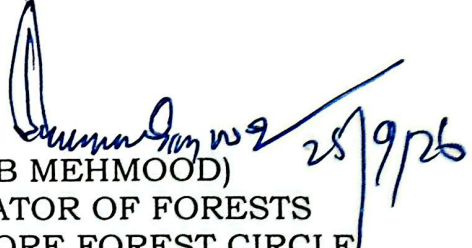

- v. Bidding shall be conducted through Single Stage-two Envelope procedures as specified in the GB Public Procurement Rules (PPRA 2022).
