Executive Engineer B&R Division C&W Department Kharmang invites sealed proposals (Technical & Financial) from engineering consultants/firm for the scheme "Feasibility Study of Lift Irrigation and Water Supply etc. in GBA-11 Kharmang". The interested firms must have proven experience of feasibility studies and detail designing of lift water system.

The Firms must have a valid registration with PEC in the relevant field and code for FY 2024-25 (or as per extended period by PEC if any) and income Tax/services Tax registration with FBR along with proof of office Establishment branch in Pakistan.
