All bids must be accompanied by a bid security as indicated above against each work and in case of rates quoted below 10% of estimated cost shall be required to provide alongwith bid an additional performance guarantee of 50% of the differential amount (between estimated cost & bid cost) in shape of **CDR/Bank Guarantee** from any schedule Bank clearly mentioning the name of firm in favour of **Deputy Director Water Management & Irrigation Department District Diامر**. The sealed bids must be delivered on due date & time as mentioned above, which will be opened on the same day in the office of Deputy Director Water Management & irrigation Department District Ghanche in presence of bidders who choose to attend at the same address.
