## TERMS AND CONDITIONS

- 1. Tender process will be completed single stage two envelope basis for each component. Thus bids must be in two separate envelops (i. Technical proposal & ii Financial proposal) clearly mentioning on the envelops; otherwise the offer / envelops shall be rejected unopened at the spot. Only technically qualified firms would be called for financial evaluation.
- 2. Bids shall be accompanied equal to 5% of offered / quoted rates as bid security in the shape of Demand Draft / Pay Order in favour of Director Gilgit-Baltistan Sports Board, from any schedule bank, however, the CDR of Karakorum Cooperative Bank (KCBL) will be accepted.
- 3. An affidavit on stamp paper of Rs. 50/- must be accompanied with the tender documents to the effect that the bidder has never been black listed by any Government / Sami Government Organization / PPRA.
- 4. Rate will be decided for item bid basis for Serial # 1 (i. e. Supply of Sports Gears / Equipments).
- 5. Rate will be decided on lot basis for Serial # 02 & 03 (i.e. Printing of Promotional Material & Hiring of Tent Service). For lot basis, reasonable market rates should be quoted for each & every item otherwise rejected.
- 6. Offered rates must be inclusive of all government taxes /foreign charges if any.
- 7. Offered rates must clearly be mentioned in type form on the tender documents / format issued by this Department. Rates offered in hand writing and other than the prescribed format shall not be considered.
- 8. For any item which is not included in bidding list, the contractor will be bound to provide the item on market rates with 10% service charges.
- 9. Incomplete, unsealed, conditional and bids received after due date / time shall not be entertained.
- 10. No advance payments shall be admissible.

11. The competent authority reserves the right to accept or reject any or all bids in the light of PPRA Rules, 2004, clause 33 (1) and GB-PPR, 2022 clause 36 (1).
