Sealed tenders are hereby invited through "Single Stage one Envelope" bidding procedure as per GBPPRA Rule 39(a) for the works mentioned below from the eligible Firms/Contractors registered with PEC in relevant category/field of specialization, renewed up to 30th June 2025. The tender document can be obtained from the office of the Executive Engineer LG&RD District Gilgit from the date of publication till 23-05-2025 during office timings. Tender fee as mentioned below (non-refundable) in the form of Cash along with 2% Bid Security in the shape of CDR from any scheduled bank of Pakistan in favor of Executive Engineer LG&RD District Gilgit to be attached with the application for issuance of tender document. Bidding Document will be issued by applying on original letter-pad by owner of firm or their authorized representative having registered power of attorney of the firm mentioning the name of project (on affidavit). No proxy will be allowed to participate. The tender document must reach in the office of the undersigned located at Shaheed-e-Millate Road Gilgit as per schedule mentioned against each and shall be opened on same day and time in the presence of contractors or their authorized representatives. Tenders received by mail courier and fax or telegraphically shall not be entertained. The undersigned reserves the right to reject any or all the tenders under GBPPRA Rule 36 of 2022. Additional performance guarantee will be governed through Clause IB 30.1 of bidding data. Non-compliance of instructions to bidder in the Tender Documents will lead to disqualification/non-responsiveness of the bid/firm. In case of gazette /Local Holiday tender will be opened on next working day without further intimation and time completion period of projects are tabulated below. Contractor can apply for only one work at a time.
