- Call deposit of 2% of tendered amount will be deposited in the shape of bank draft in any scheduled bank in the name of Social Welfare Officer, Social Services Medical Center (SSMC) PHQ Hospital Gilgit.
- 5. An affidavit on stamp paper not less than Rs. 200/- must be accompanied with the tender for not being black listed from Govt/ Semi Govt. organization/ PPRA.
- 6. The procurement committee reserved rights to accept or reject of all bids or proposal in the light of PPRA Rule-36(1).
- 7. Bidders for Local Purchase of Medicines should have medical license with from. C for medicines suppliers. The bidder should have the medical shop only at PHQ Hospital Chowk Gilgit.
