

NOTICE INVITING TENDERS

The Communication & Works Department Gilgit-Baltistan, B&R Division Nagar Gilgit Region, invites sealed tenders under Single Stage One Envelope (SSOE) procedure for the following works from the eligible Firms/Contractors Licensed by Pakistan Engineering Council in appropriate Category C6 & Above valid up-to 30th June 2026 with specialization in relevant code:

2. Bidding documents can be obtained from the office of the undersigned on submission of tender form fee through treasury challan as shown against works (non-refundable) on any working day as per following terms and conditions:
 - i. Original departmental No litigation/No sick scheme certificate on the behalf of office of the Secretary Works C&WD in prescribed format for year 2025-26.
 - ii. Original renewal receipt in Works Department GB is required for the financial year 2025-26.
 - iii. Copy of National Identity card (owner of the firm).
 - iv. Only project specific power of attorney on the behalf of CEO/MD/Director of firm is accepted if provided on judicial stamp paper duly sign and stamp by 1st Class Magistrate.
 - v. Firm/JVs must provide 1% earnest money in the form of call deposit receipt (CDR) in favor of the Executive Engineer B&R C&WD Nagar from any scheduled bank.
 - vi. In case of receipt of abnormally low bids below 15% from technically sanctioned cost, the bidder must provide an additional performance guarantee (differential amount equal to 10% of the difference amount between bid and TS cost) in shape of CDR only from any schedule bank of Pakistan in favour of the Executive Engineer C&WD GB B&R division Nagar as indicated in NIT which should be submitted along with the financial bid and insurance guarantee will not be entertained for this purpose.
 - vii. The bids having bid price lower than 25% shall be liable to be rejected. In case of same disputed rates within 25%, initially rates upto three decimal places shall be assessed for the competition. In case of further dispute/ deadlock, it will be decided through a toss/draw as per directives vide Chief Engineer, C&W Gilgit Region File No. E6-1(195)Cir/2025-26/2919 dated 07th November, 2025.
