- i. Location: Office of DG, GBDMA HQ's Minawar, Gilgit, Gilgit Baltistan.
- ii. Issuance: Documents will be issued from 02-10-2024 to 18-10-2024 up to 09:30am
- iii. Submission: Last date will be 18-10-2024 up to 10:00am
- iv. Opening: Will be opened on 18-10-2024 at 10:30am
- 2. Method of Procurement: Single Stage TWO Envelope (SSTE). (PEC Harmonized with GB PPRA Rules).

3. Terms and Conditions:

- a. Under following conditions bid will be rejected:
 - i. Conditional and telegraphic bids/tenders.
 - ii. Bids not accompanied by bid security and form.
 - iii. Bids received after specified date and time.
 - iv. Bids of black listed firms.
 - v. Unsealed bids or wrongly marked bids (Technical and Financial).
 - Vi .Valid PEC Registration Certificate valid for current financial year with relevant category and codes of specialization.
 - vii.Attested latest profile of the Contractor.
 - viii.CNIC of the prospective bidders.
 - ix.Affidavit of no litigation and no blacklisting.
 - x.Performance certificate from GBDMA.
 - xi..The Tender Documents /RFP containing detailed terms and conditions, method of constructing/supply procedure for submission of bids, bid security, bid validity, opening of bid, evaluation criteria, clarification/rejection of bids, performance guarantee etc. can be obtained from the Office of DG Gilgit Baltistan Disaster Management Authority, Near GB Scouts HQ's Minawar Gilgit, Gilgit Baltistan.
 - xii. Have experience in execution of at least 4x similar Projects.
 - xiv.If any member of the Procurement Committee remains out of head quarter on date of opening of tenders, the same will be opened on the next working day at the same time as mentioned above.
 - xv. Firm must have bank balance of at least 50% of the value of the project.
 - xvi In case of any conflict GB PPRA Rules 2022 shall be major rule having effect

xvii.Rates quoted below or equal to 5% of the technical sanction (TS) shall be considered as unworkable.

xviii.In case of JV agreement, proper format duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1st Class shall be mandatory.

- vii. Bid security as specified in shape of CDR from any schedule Bank of Pakistan.
- viii. Procurement/Supply/Construction shall be carried out in accordance with the policy and guidelines issued from time to time by the GBDMA.
- ix. The prospective eligible bidders may obtain bidding documents after payment of price of bidding documents and by submitting a written application personally or through an authorized representative with duly attested copy of power of attorney. Power of attorney for bidding should be in rupees RS: 100/-stamp paper in original mentioning the project name with employer stamp.
- x. In case of firm, list of partners/partnership deed, giving full particulars of Director/ Proprietor or other connected along with power of attorney or being sole proprietor such undertaking on affidavit is to be furnished.
- xi. NOC of No Sick project from GBDMA, Works Department, GDA, Education Department, ETI, Water & Power & LG&RD.
- xii. The proposals accompanied with bid security must reach in sealed envelopes by hand or through registered mail to the Office of the Director General GBDMA HQ before closing date and time as above and be clearly marked Bid/proposal for "Repair/Renovation of Safe Havens in GB 2024.

The Procuring Agency reserves the right to reject any or all bids subject to relevant provisions of GB PPRA Rules, 2022 The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Rule-36" of said Rules.
