### CONDITIONS

- i. Registration with PEC in relevant category duly renewed for the year 2024-25.
- ii. The Firm / Contractor must be enlisted with Water & Power department Gilgit-Baltistan. In case of JV, at least one of the partners must be enlisted.
- iii. Original letter of authorization from the international manufacturer or its authorized dealer to be provided for Solar Panels and Inverters.
- iv. Undertaking for No-blacklisting on the letter head of firm may be provided.
- v. The specific codes EE-06 and EE-11(i)(ii)&(iii)(Solar) for serial No. 01 and EE-05 and EE-04 for serial No. 02 & 03 are mandatory.
- vi. The Employer invites sealed bids under single stage two envelopes for serial No.01 and Single stage One envelop for serial No. 02 & 03, from eligible firms or persons having above mentioned codes and licensed by the Pakistan Engineering Council in the appropriate category for the above-mentioned works. A foreign bidder is entitled to bid only in a joint venture with a Pakistani contractor in accordance with the provisions of PEC (bye-laws).
- vii. Bidders may obtain sample BOQ (2-3 pager) and further information about conditions given above and eligibility to acquire the Bidding Documents from the Office of the Employer.
- viii. A complete set of Bidding Document may be purchased by an interested bidder on submission of a written application(In-person or with POA) , earnest money deposit EMD (that will be released following the issuance of commencement order to the first lowest bidder) and payment of a non-refundable tender form fee mentioned against each in the shape of Deposit at call by a schedule bank and Bank draft in the name of Executive Engineer W&P Division Ghanche respectively, three days prior to the date of submission.
- ix. All properly sealed bids for serial No.01 must be delivered to **Conference Hall Regional Office W&P Skardu Hassan Sadpara Chowk (Pareshan Chowk Skardu)** and for serial No.02 & 03 to **(Divisional office of the Executive Engineer W&P Ghanche Siachen Road Khaplu)** at the mentioned date and time.
