- 1. PCATP/ PEC valid registration for CFY 2024-25.
- NOC "No Sick Project" from Skardu Development Authority (SDA) for the firms worked with SDA before.
- CNIC of prospective bidder/firm.
- 4. Required bid security (CDR) mentioned against each work from schedule bank of Pakistan as per GB PPRA rule # 28. Pay order is not acceptable.
- 5. Late submission of bid will not be entertained.

## TERMS & CONDITIONS

- The sealed bid shall comprise of a single package containing two separate sealed envelopes, each envelop shall be marked separately as, "Financial Proposal" and "Technical Proposal" in bold and legible letters to avoid confusions.
- Bidding documents, containing detailed terms and conditions can be obtained from office
  of "Director Works, SDA Skardu" by paying the fee mentioned above during office hours
  from 01-02-2025. Bidding documents will not be available on or after date of bid opening.
- 3% bid security in shape of CDR from scheduled bank should be submitted along with technical proposal in name of Director Works SDA.
- 4. The sealed bids prepared in accordance with instruction in the RFP must reach at the office of the undersigned on or before the closing date.
- Financial bids will be opened, if the bidders qualify technically, and fulfill mandatory conditions mentioned in the RFP. Detailed ToRs are available along with the RFP.

- 6. Conditional / telegraphic tender shall not be accepted.
- 7. All taxes shall be deducted as per prevailing rules of Govt of GB.
- 8. Tender documents shall only be issued to the bidders or their authorized representatives on production of his/her Original CNIC having valid power of attorney in original. The employer reserves the right to verify the power of attorney before the issuance of tender documents.
- 9. In case of firm/company/JV, registered power of attorney and partnership deed in original duly attested must be submitted. In case of Joint Venture, the approval of most advantageous bid is subjected to the provision of joint account & valid IBAN Number of the JV account.
- 10. The successful bidder shall provide performance guarantee @10% & Insurance guarantee @1% of the bid amount from any schedule bank of Pakistan or Insurance Company having "AA" rating.
- 11. The employer reserves the right to accept or reject any bid and the bidding process and reject all bids with reasons thereof (if any).
- 12. The bid should be valid for 90 Days.
- 13. In case of Gazette /Local holiday, tender shall be opened on next working day without further intimation.
- 14. In case of any deviation, conflict in bidding procedure, the provision of PEC & PPRA rule shall prevail. The appealing authority shall be the one whom rested the power of bid acceptance.
