Gilgit-Baltistan (GB) Parks and Wildlife Department is intended to conduct comprehensive wildlife survey in Gilgit-Baltistan. Therefore, the Department invites Expression of Interest (EOI) for the consultancy service to carry out wildlife survey/census in Gilgit-Baltistan, Pakistan.

The Department now invites national & international eligible consulting firms/ organizations /institutions to indicate their interest in providing the services.

1. The consulting firms/organizations/institutions must have valid SECP registration with at least five (5) years of experience in providing similar services, should have documented track of completing at least two (2) similar assignments of comparable scale and complexity.
2. The consulting firms/organizations/institutions should have strong relevant national or international experience and understanding in conducting wildlife survey and census.
3. The consulting firms/organizations/institutions should have associated team of technical experts with required qualifications and experience as mentioned in the bidding document and be able to engage required operational staff as per detailed ToR of this assignment.
4. The consulting firms/organizations/institutions may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
5. The consulting firms/organizations/institutions shall be selected in accordance with the Quality and Cost-based Selection (QCBS) method under Procurement of Consultancy Services Regulations, 2010, of Public Procurement Regulatory Authority of Gilgit-Baltistan.

Interested consulting firms/organizations/institutions are required to submit EOIs, comprising of three hard copies along with digital copy, on or before 06-01-2026 in the office of the Chief Conservator Parks and Wildlife GB office at the following address and digital copy be mailed at email address: [ccpw@fwegb.gov.pk](mailto:ccpw@fwegb.gov.pk), by 1600 hrs of the deadline, the latest. In case the last day of submission falls on national/gazette holiday, EOIs may be submitted on the next working day. The expression will be opened on 07-01-2026 at 11: 30 am. This Expression of Interest does not constitute a Request for Proposal (RFP), and only shortlisted firms will be invited to submit detailed technical and financial proposals.
