TERMS & CONDITIONS

01. Sealed tenders single stage two envelopes procedure containing two separate envelopes marked as **Financial Proposal** and **Technical Proposal** in bold must be submitted. All bids received shall be opened and evaluated in the manner prescribed in bidding documents.
02. Tender will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at Governor's House Gilgit-Baltistan, Gilgit.
03. Contractors/Suppliers may offer only for that category of tender in which they have complete setup (Own Shop/Store/Work Shop) with all documentary evidence. The existence of setup will be physically verified.
04. The contractor/supplier must have adequate supply/stock in Gilgit Town and the firm will be bound to supply demanded items/ Services at Islamabad and other camp offices on the same rates as well.
05. The contractor shall be required to have all repair and maintenance work for the VIP Vehicles of the Governor House carried out exclusively at authorized Toyota workshops.
06. As the Government vehicles of the Governor's Office deployed at the Camp Office, Islamabad, are maintained in Islamabad, the supplier/contractor shall make necessary arrangements for their repair and maintenance at Islamabad as and when required.
07. The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of **Military Secretary to Governor** Gilgit-Baltistan be attached with the technical documents. Tender without call deposit from a schedule bank will not be entertained.
08. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
09. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevailing retail price/market rate at the time of supply.
10. Duly attested documents i.e. One year Bank Statement, Call Deposit, Eight Years Work Experience in relevant field (in Government and Semi Government's well reputed registered organization), Firm Registration Certificate, Non Black Listed Affidavit, CNIC of the owner, Letter Pad of Firm with address, Vendor Number & Telephone Number must be attached with technical bidding documents.
11. Only Experience Certificates issued by the concerned departments will be accepted. Supply Orders shall not be considered as a substitute for Experience Certificates. All Experience Certificates will be verified from the respective departments.
12. Irrational/artificial and dubious rates offered by the firms/contractors will be rejected.
13. All kind of taxes applicable (if any) will be inclusive in the bid price and will be borne by the firms/dealers/suppliers/contractors.
14. The Competent Authority reserves the right to accept or reject any one or all the tenders as per relevant instructions/guidelines of GB PPRA Rules, 2022.
15. The successful bidder shall be required to furnish a Performance Guarantee equivalent to 10% of the total contract amount.
