Terms & Conditions: -

1. Sealed tenders may be submitted to undersigned before closing date and time, which will be opened by the committee on the above-mentioned date and time in presence of the contractor/suppliers or their authorized representatives at DPO office Ghizer.
2. The Contractor/Supplier should have his complete set up (own shop/workshop, technical experts/staff, vast and past experience with documentary evidence).
3. The Contractor/Supplier must be sole proprietor having his own complete setup (shops, workshop) containing adequate supplies in Gilgit Town as well as at Islamabad or authorized dealer/agent at Islamabad and will be bound to supply demanded items at the DPO Office Ghizer.
4. The Bid Security/call deposit in shape of Bank Draft/Pay Order of a scheduled bank in the name of **DPO Ghizer** may be attached with the bidding/tender documents, without call deposit from a scheduled bank, tender will not be accepted.
5. The bidding document of only registered Government contractor shall be entertained.
6. The rates of items if not covered in the "Prescribed Form" will be determined in accordance with the prevalent retail prices in the open market at the time of supply.
7. All kinds of Taxes applicable (If any) will be inclusive in the bid price and borne by the contractor.
8. Conditional, ambiguous & incomplete tenders shall not be accepted.
9. Work experience in relevant field, Registration Certificate and Vendor Number duly attested must be attached with bidding documents.
10. The Competent authority reserves the right to accept or reject any one or all the tenders as per instructions/guidelines of PPRA Rule-33(1).
