2. The tenders will be opened on the given date & time in presence of the contractors/Suppliers, or their authorized Reps
3. Name of Category must be written in bold on the sealed envelope.
4. A Firm/Contractor/Supplier may offer tenders for one or more categories.
5. The sealed envelope of tenders must contain the following documents, without which the tender will be liable to be rejected.
  - i) Tender must be in the Firm's letter paid with vender number.
  - ii) Call Deposit from a Scheduled Bank.
  - iii) Registration certificate of firm, with latest renewal (if any)
  - iv) Copy of CNIC of the owner.
  - v) Rates of items must be filled in computerized.
  - vi) Rates of items must be in accordance to the market.
6. The rates of items if not covered in the "Tender Form" will be determined in accordance with the retail price fixed by the Chairman Price control Committee, Gilgit/Market Rates.
7. Govt. Taxes applicable (if any) will be borne by the Firm/Contractor/Supplier.
8. Cost of Tender Copy/Bidding Documents must be deposited through treasury challan and attach the copy of challan with the Tender Copy/Bidding Documents and submit to this department on due date.
