Executive Engineer B&R Division C&W Department Kharmong invites sealed proposals (Technical & Financial) from engineering consultants/firm for the scheme **"Feasibility Study of delta bridge at Kharmang Khas and Hamzigound and Truckable road from Pari to Changmer GBA-11 Kharmang"**. The interested firms must have proven experience of feasibility studies and details designing of RCC bridges on major rivers, detail designing of roads, highway and other allied structures.

The firm must have a valid registration with PEC in the relevant field and code for FY 2024-25 (or as per extended period of PEC) and income Tax/services Tax registration with FBR along with proof of office Establishment branch in Pakistan.

Interested firms may obtain the RFP documents from the office of the undersigned at Kazburthang Mehdi Abad kharmang during office hours (0900 hrs to 1600 hrs) upon submission of non-refundable fee of Rs. 5000/- up to **27th Feb, 2025**.

The bidder should visit the project site to get acquainted with the existing conditions and to get familiar with the quantum of work and nature of assignment. A joint visit to the project site can be arranged on request.

Single Stage-Two envelope procedure will be adopted as per **GB-PPRA Rule 2022 39 (b)**. One envelope containing technical proposal should be clearly marked as **"Technical Proposal"** and the second envelope containing the financial proposal should be clearly marked as **"Financial proposal"**


The envelope of **"Technical Proposal"** should be accompanied with an amount of Rs. 0.600 million as bid security in the form of Deposit at Call in favor of Executive Engineer B&R Division C& WD Kharmong. Partial and incomplete bids will not be considered. **"Technical Proposal"** and **"Financial Proposal"** (both envelopes) are to be submitted at office of the Executive Engineer B&R Division C&WD Kharmang Kazborthang Mehdiabad. the by 28th Feb 2025 till 04:00 PM. The envelopes containing the technical proposal shall be opened on **29th February 2025** at 02:00PM in the office of the Superintending Engineer Kharmang/Ghance Circle near balto Rest house skardu in the presence of those bidders who choose to be present. Proposals received after the described time and date shall be rejected.

The envelope of **"Financial Proposal"** of the firms who fail to technically qualify shall be returned unopened.

The envelope of "Financial Proposal" of only "Technically Responsive and Qualified Firm" will be opened in the presence of their respective representatives at the date and time to be determined and communicated later on.

All the applicable Federal/ Provincial taxes must be considered while preparing the Financial Proposal and are required to be built in the quoted rates and not be mentioned separately. Provision of forged, fake, false, unsubstantiated, incomplete information may lead to deduction of marks and disqualification or blacklisting.
