MANDATORY CONDITIONS:

The bidder shall be screened out in the preliminary checking subject to not fulfillment of all conditions, rendered as under:-

1. PEC valid registration for CFY 2023-24.
2. PEC relevant Category and Code.
3. CNIC of the prospective bidder.
4. Enlistment with Procuring Agency.
5. Affidavit of No Blacklisting from any organization.
6. Receipt of renewal fee for 2024-25 (in original).
7. Signature of bidder / witness on bidding documents is mandatory.
8. Late submission of bid will not be entertained.

TERM & CONDITIONS:

1. The bid security 2% of Engineers cost estimate in form of Call Deposit issued by a scheduled bank of Pakistan in the name of XEN B&R Division GB C&WD Skardu valid for a period of 28 days beyond the bid validity period.
2. Conditional tenders shall not be accepted.
3. In case of firms / company / joint venture, registered power of attorney and partnership deed in original must be produced for issuance of tender documents, J.V agreement on proper format duly signed by all partners of JV, clearly mentioning share of each partner and lead partner duly attested by Magistrate 1st Class shall be mandatory.
4. The employer reserves the right to accept or reject any bid and the bidding process and reject all bids with reasons thereof (if any).
5. In case of holiday, tender shall be opened on next working day without further intimation.
6. Rates quoted below 10% of the Technical Sanction shall be considered as unworkable; however,
 - a). The bidder quoting rates below 10% of T/S shall be required to provide along-with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR from any schedule Bank.

- b). In case of failure to produce the required differential amount of the bid by the bidder along-with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited.
7. The tender revised policy 2022-23 circulated by Works Secretariat vide letter No. Sec-SO-D-9(28)2022-23/1475 dated **26th January 2023** will be followed.
 8. The bidders can submit application up to **(09th September, 2024)** during office hours. After that, no application will be entertained. The application will then be scrutinized by the Divisional procurement Committee and then bidding documents will be issued. The bid documents will be issued on production of original 2% earnest money(CDR) with its copy attach and **treasury receipt Challan** with cost of tender form as mentioned against work which can be received from the office of the **Executive Engineer B & R Division GB C&WD Skardu** during office hours.
 9. The bidders who possess in hand schemes in this division with delayed incomplete works without valid reasons either individually or with J.V agreement will not be eligible for participation in the above bid.
