- iv. The bidder shall provide color broacher and complete specification of quoted equipments and also provide authority letter from manufacturers /authorized distributors.
- v. Warranty period will be at least two years. Rates will be inclusive of all relevant taxes.

- vii. As per GB-PPRA Rules 2022 Clause 39 (b) single stage two envelope bidding procedure will be adopted for this national competitive bidding.
