- 1. The interested bidders will submit their bids on 22nd April, 2025 at 11.00am (Tuesday), which will be opened at 11.30am in presence of bidders/ suppliers or their authorized representative in the office of the District Health Officer Ghanche, Khaplu.
- 2. The bidder can obtain bidding documents from the office of the undersigned on written request and payment of as per Gilgit Baltistan Finance act 2023.
- 3. 4% bid security in the shape of Call Deposit (CDR) in the name of the District Health Officer Ghanche must be accompanied the tender/bids and the same will be remained with this office till completion of successful supply and expiry of warranty period.
- 4. The bidders shall provide color broacher and complete specification of quoted equipment and also provide authority letter from manufacturers/authorized distributors.
- 5. Warranty period will be at least 01 year. Rate will be inclusive of all taxes.
- 6. The procuring Agency reserves the right to increase/decrease the quantity or delete the items.
- 7. In case of any dispute, the decision of the purchase committee will be considered final and will not be challengeable in any Court.
- 8. As per PPRA Rules 2022 Clause 39(b) single stage two envelopes bidding procedure will be adopted specially for medical equipment and machinery.
- 9. For lot of medical equipment/instrument only those shall be eligible who have PEC Certificate (ME 06).
- 10. Contractors/bidders will be responsible to provide/supply the purchased items to respective Health Facility of District Ghanche after physical verification.
- 11. Final payment of the supplied items will be according to the physical verification report made by Purchase Committee of this office.
- 12. No tender documents will be issued to agents who desire to purchase Bidding Documents without Original Power of Attorney of any contractors.
- 13. If the tender cost submitted by contractors/suppliers exceeds from the estimated cost, the authority reserves the right to reject /cancel the tender.
- 14. Supply order will be issued subject to availability of release of fund.
