- iii. The Bid Security / Call Deposit in shape of Bank Draft / Pay Order of a schedule bank in the name of the Deputy Secretary (Dev.) Social Welfare, Population Welfare, Women Development, Human & Child Rights and Youth Affairs Department, Gilgit-Baltistan. Call deposit of Karakoram Co-operative Bank shall also be accepted.
- iv. Offer must be in Pak Rupees inclusive of all Taxes Applicable (if any), Transportation Cost to respective District Headquarters / Tehsils whatsoever. No any additional claim shall be accepted.
- v. Conditional, ambiguous, incomplete and hand written tenders shall not be accepted.
- vi. The Committee reserves the right to cancel bids for irrational rates as per rules, policy and procedures accordingly.
- vii. Rates should be for genuine items and contractor will be bound for warranty where required.
