TERMS AND CONDITIONS:

1. The bidding documents will be issued firm/contractor after scrutiny of documents by the committee and upon submission of 3% bid security in shape of CDR issued by any schedule bank in Pakistan. The contractor/owner of the firm must collect document in person or by the authorized representative having original power of attorney mention the name of above project fulfilling's mandatory and general terms and conditions.
2. Rate quoted below 10% upto 25% of the Technical Sanction shall be required to provide along with his bids an additional performance guarantee of 50% of the deferential amount (between TS and Bid) in shape of CDR form any schedule Bank of Pakistan. The CDR must be prepared from Owners Bank account otherwise not accepted.
3. No bid shall be accepted beyond closing time as mention against each work.
4. In case of Gazetted Holiday/Local Holiday/Surprise engagement tender shall be opened on next working day without further intimation.
5. Bid shall be opened in the Office of the Executive Engineer LG&RD Ghanche.
