03. The firm who has complete setup i.e workshop/shop in Islamabad or Rawalpindi may participate in bidding process.
04. The Contractors/Suppliers must be sole proprietors as well as Tax payers with GST/NTN registered.

The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of Drawing & Disbursing Officer Implementation and Coordination Department (GB), Islamabad be attached with the technical documents. Tender without call deposit from a schedule bank will not be entertained.
06. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
07. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevailing retail price/market rate at the time of supply.
