CIRCULAR

I am directed to inform that Gilgit-Baltistan Public Procurement (GB-PPRA) Rules have been implemented and official website has also been launched and conveyed to all departments. It has been observed and brought into our notice by Accountant General Office, GB that Departments do not abide by the Rule-7 of the GB-PPR, 2022 which is reproduced as under:

"The procuring agency shall, with approval of its head of the department, constitute as many procuring committees, as it deems fit, each comprising of odd number of persons and headed by an officer not below the rank of BS-18 or if not available the officer of the highest grade, and shall ensure that at least one third of the members of a procurement committee or from the agencies or departments other than the procuring agency."

- 2. Therefore, it is requested to implement GB-PPRA rules in true letter & spirit and committee composition as given in above mentioned rule may strictly be followed.
- 3. In future, this authority shall not entertain any case from Departments for relaxation of any rule/clause of Gilgit-Baltistan Public Procurement Rules, 2022.
